

A peaceful practice was declared "Enemy of the State"

In 1992, Falun Dafa was introduced to the public in Northeastern China by teacher Li Hongzhi. The Chinese Ministry of Health started to strongly endorse the free-of-charge practice after discovering its powerful effects. By the end of the 1990s, over 70 million people from all social classes had started to practice Falun Dafa. www.falundafa.org

Practitioners believe in "truthfulness, compassion and forbearance" and have no political agenda. However, the practice is part of traditional Chinese culture. As the number of practitioners exceeded that of Communist Party members, president Jiang Zemin started to consider such cultural renaissance as a "threat" to the Party's ideology. Falun Dafa was banned in July 1999. The Party launched a multi-billion dollar campaign of persecution and propaganda in all of Mainland China. The persecution is still going on. Chinese embassies around the world try to suppress efforts to raise awareness of the Party's crimes. www.faluninfo.net



Independent research puts forth strong evidence

China harvests organs from living prisoners of conscience



In 2006, Canadian human rights lawyer **David**Matas, together with Canada's former Secretary of State and Crown prosecutor **David Kilgour**, published an investigative report called Bloody Harvest: An Independent Investigation into Allegations of Organ Harvesting of Falun Gong Practitioners in China. The report has been supplemented with new circumstantial evidence in the recent years. In collaboration with doctors and other researchers, a book consisting of 11 articles was published in 2012: State Organs: Transplant Abuse in China.

The researchers' core allegation is as follows. Since the mid-1990s, the Chinese government has used countless **prisoners of conscience** as a live "organ bank". Innocent people have been subjected to blood testing and physical check-ups to determine their compatibility with patients in need of a liver, kidney, heart or other transplant. When suitable matches are found, **the prisoners are murdered by harvesting their vital organs in secret operations**.



- Chinese doctors in 14 different provinces have admitted in recorded telephone conversations that their organ transplants come from imprisoned Falun Gong practitioners.
- 2. A Chinese surgeon's ex-wife has witnessed that her husband removed the cornea of 2000 Falun Gong practitioners in the city of Shenyang between the years 2001–2003.
- 3. Even though prisoners of conscience are often abused and tortured to death, their blood is tested and internal organs are systematically monitored in China's forced labor camps.
- 4. Transplants are available in China within a matter of days or weeks. Elsewhere in the world, the waiting times are counted in years.
- 5. Organ trade is extremely lucrative business. A Chinese transplant website advertised kidneys for approximately \$120,000 and hearts for approximately \$150,000.
